#### 5.1 Fire Investigation Report

- FIU working out details on adding an investigator for Turlock.
- Chief Murdock and Chief Ernst stated there have been discussions of moving FIU from the DA's office to Modesto Fire - daily management of employees – same structure – nothing would change.

## **5.3** Fire Communications Report

- A detailed summary report was included in the agenda packet.
- CAD/MDC issues the new process is to call Sheriff's IT, they will create a ticket and assign it to Chad Homme. Chad then can triage/resolve or push it up the chain. This will provide a process to track the tickets.
- AB109 update: The tower on Frymire will only need to be 65 feet tall, which should save on costs and lease.
- Diablo Grande Kurt and Nate from SR911 submitted the County's latest requests to Planning over 2 weeks ago and are awaiting a response.
- Radio reprogramming drafts are done, will be sent for review later today.
- Radio orders be sure to order early, lead time is as much as 6-7 months for radios and components.

• Fire Warden's office is providing admin support to Stanislaus Consolidated Fire – any District is eligible for these services.

• State OES added a type 6 engine to go along with the HazMat unit

#### 5.7 Training

- Introduced Mike Lunn, the new Fire Training Coordinator
- Training on the new Bambi bucket will be coming out to agencies soon
- County training officers meeting will be on Sept 7<sup>th</sup>
- Ripon Fire has 3 commercial buildings available for training
- Mike Lunn has been added to the Duty Officer list

- Hired an EMS Coordinator for Quality Improvement, an EMS Technician and an EMS Administrative Clerk, all three are in backgrounds.
- There are 3 medics in EMS that will be able to respond to ALS calls
- The new EMS Certification/Accreditation portal is live online and going well.
- Preceptors (Paramedic FTO's) in Fire developing a policy to get them approved through EMS agency to raise the standard of care.
- Mobile EMS App in process of purchasing and should have it up and running in the next few months (Training to follow upon acquisition)
- BLS Tiered Response units approved to respond to 5150/Psych calls with Law Enforcement that have no medical complaint
- APOT and APOD policy drafts APOT time decreased to 20 minutes, anything above will be APOD
- Immediate to Waiting Room Policy in draft with APOD, help mitigate APOT
- Draft policies are online for comment

#### 5.9 SR911

- There are 9 dispatchers in backgrounds and there is an academy in process
- 2 lateral dispatchers are now working
- The new Deputy Director Kasey Young will be starting Sept 12<sup>th</sup>
