### 4. Agenda Items:

# 4.1 Consideration for approval of funding for: MST Hazmat Materials/Tech Rescue Team Support, presented by City of Modesto Fire

A PowerPoint presentation was given by Chief Bartley with an overview of MST Hazmat Materials/Tech Rescue and their relationship with the county.

Chief Wise further explained what they offered as an incident management team and that they have MOU's with several agencies and are willing to have more agreements with agencies or individuals who are interested.

Chief Parnell asked what the number of HazMat and Tech Specialist calls were made outside of district. The reply was that they are listed in the quarterly reports, but they did not know figures to offer at the meeting. Chief Frye asked why there was a need to have a Special Meeting for this item and he was informed that it was a previous agenda item but had not been addressed in time prior to the expiration of the current contract, which will expire on February 1, 2024.

Chief Tietjen explained an incident they used the Hazmat team that involved a roll over propane truck and included over eighteen hours of mitigation. He also added that a district may not feel they would use the team but if the time does come, they will be thankful that they have that security.

A question was presented as to what the call down order was? Flow chart? Chief Bartley responded that to start by calling Station 4 and they may be able answer your questions, direct you to the appropriate contact or they will respond, if necessary. Also, dispatch can be called, they have them built into the system.

Chief Parnell asked for approval of the three-year contract costing RFA \$250,000 annually. He asked if any were opposed to the agreement, none were opposed, passed unanimously by representatives.
